Pool Proposed Updates and Changes for Next Season – After many misconduct incidents, some vandalism and due to misuse by some, policy changes are being considered. We have posted proposed policy and rule changes in this month's newsletter for the second time on pages 6 - 9. We are seeking comments and feedback from the community regarding the possible changes. Once the revised policy has been determined, changes are slated to be included with a revision to our house and ground rules. We are seeking to improve the member experience by creating a reliable, safe, clean, family-friendly and dependable environment. Key recommendations include designating the "Swim and Racquet Pool" for adult Swimmers only outside of swim team use as well as adding pool gate marshalls as a budgeted item for next year's season.

Pool Gate Marshalls – Recently, the POA placed security gate marshalls at Montclair Pool. Feedback from members was positive. Security gate marshalls were approved for some weekends thru Labor Day. Reminder, you must have a working Pool Gate Entry Magnetic Proxy Card. If your card does not work, please stop by the POA office to replace it. Pool Gate Cards are issued to members of our POA that are in good standing. Violation of existing pool policy could lead to suspension of privileges.

Pool Policy (Current) – Typically, our pools are slated to be open beyond Labor Day weekend and remain open into October. We close once the weather is not conducive to use. Current Pool Use Rules allow up to four non POA guests and they must be accompanied by the POA member. Also, no one under the age of 16 is allowed without an adult member present. Members and their guests use our pools at their own risk.

To set up your login please contact the POA office at 251-626-0788. For our current budget month, the POA was reported as under budget for this calendar year.

BURGER NIGHT at the 19th Hole Grill- Beginning soon, the 19th Hole Grill will extend hours each Wednesday night and offer discounted burgers. See flyer in this digital newsletter on page 3.

Marina D – Dock Safety Repairs – Recently, minor safety repairs for D- Dock were undertaken in response to increased small boat traffic and visitors since the Waterfront restaurant and renovated boat ramp have opened.

Lake Restoration News - Recently, the Lake Forest Lake was moved into the Lake Forest Preservation 501C3 allowing for broader grant application submittal opportunities.

Standard Operating Procedure SOP - For spending on Non-Budgeted Emergency need mems, maintenance items and Capital Improvement and or Renovation Projects. The POA is developing and looking to adopt a more "formal policy" for spending that occurs on non-budgeted items. Once the language has been finalized the SOP will be publicized for member input and feedback. Much of the language being considered for the formal SOP takes into account many of the practices that have been followed and in use by our POA for many years.





LFPOA POOL USE MEMBER POLICY AND REGULATIONS

Our pool use policies and regulations are under review by our board and our management team to provide recommended changes that will strive to improve our member experience and allow our community to create and maintain a safe, family friendly environment at our pools.

Currently all our Pools are posted with signage that include our current pool use rules and also indicate that use is "at your own risk".

Recently a Pool Committee was established to review our pool use rules and regulations and to bring forth plausible policy changes. The committee coalesced around a few items that we could implement in the short term and long term. The committee gathered insight from a guest speaker that had served our POA previously as a pool Marshall who provided many insights and observations that were helpful.

Any change to one of our amenity items, including our Pools, should, when implemented strive to "improve the member experience". Changes are being considered as a response to longstanding systemic behavior and misuse complaints from members.

Member review feedback for pool policy changes is requested.

Goal: provide a safe, clean and family friendly environment for our members and their guests to enjoy our pools

Policy changes that could result in additional operating costs would need to be budgeted for in upcoming years. Policy changes attempted to be implemented for this current pool season could result in an unplanned budget expense for this current year.

"member" is defined as:

- 1. a homeowner resident member in "good standing"
- 2. or a "renter" that has been registered with the office and purchased a "non-voting membership"

Note: a "renter" can only purchase a "non - voting membership" if and only if, the actual homeowner of the residence is also a "member in good standing"; which is validated by office staff at time of purchase. The \$100.00 rate for a "non-voting membership" is being re-visited as part of this review and may be subject to a future cost increase.



Pool Policy Use "PROPOSED CHANGES"

Note: POA member resident owners "in good standing" and "renters" must purchase a POOL **GATE ENTRY PROXY CARD** at the POA office.

GATE ENTRY CARD COST:

Original CARD Fee: To be determined during annual budget review Renewal CARD Fee: To be determined during annual budget review

At the end of each pool season all cards will be "turned off" and deactivated.

Prior to the beginning of each subsequent pool season members will have to visit the office to renew or obtain a CARD. At the time of issue or re-issue members will be required to sign the updated pool policy house and ground rules and a signed copy will be kept on file at the office.

SWIM AT OWN RISK POLICY: our pools are a swim at your own risk.

ADULT ONLY SWIM HOURS: members age (18) and above "ONLY" from 6 am to 9 am daily all pools will be open for adult swim (note; for Swim and Racket Pool this will be available on days where swim team is not holding morning practice; normally Saturday and Sunday) For swim team schedule please see POA digital newsletter. Swim and Racket Pool is proposed to be an adult only pool outside of Swim Team hours.

FAMILY MEMBER SWIM HOURS: all pools open daily from 10 am to 8 pm. Note; Swim and Racket pool will be available for members outside of hours when the swim team is not holding practice or holding a swim competition event.

POOL GATE ENTRY CARD USE: members will be required to have in their possession an active GATE CARD upon entry and have their POA member card on hand. Please see the LFPOA office to get an updated membership "SILVER" card.

POOL SUSPENSION OF USE PRIVILEGES: illegal entry, holding gates open for non-member visitors as well as unruly behavior or violation of pool policy and house and grounds could result in suspension of pool privilege.

POA MEMBER GUESTS: members in good standing are allowed up to 4 guests only.

Pool Policy Use "PROPOSED CHANGES" contd

PARTIES: pool parties will be permitted at Swim and Racket Pool "ONLY" from 11 am to 2 pm on Sundays. Reservations are required with the office. A deposit will be required. A portion of the deposit will be non - refundable. A portion of the deposit will be refundable. Once the scheduled pool party has concluded a Pool Gate Marshall or Management will ensure the area has been cleaned and that no damage may have resulted from the party activity. Parties will no longer be allowed inside the gated pool areas at Montclair Pool or Ridgewood Pool. Pavilions at Montclair and Ridgewood are first come first serve.

PARENTS OR GUARDIANS: are responsible for conduct and oversight of member users under the age of 16. Unruly conduct, misbehavior or vandalism of any type will not be allowed and WILL lead to suspension of pool privileges. Reports to local authorities when appropriate will also be made.

INFANT SWIMWEAR REQUIRED: children and infants not toilet trained must wear specific swim diapers with rubber pants over them to use any pool and kiddie pool at Ridgewood Pool.

POOL GATE "MARSHALLS": will be onsite for all (3) pool locations daily. Gate Marshalls shall monitor entry gates to ensure users have a working ENTRY CARD and active POA Membership Card. GATE Marshall's shall also observe pool conduct and respond appropriately to correct or report activities that are not in keeping with the enjoyment of our members or are unsafe, unruly, or otherwise offensive or could led to damage of property. Marshalls shall ensure the pool deck is cleaned, free of debris and furniture is returned to the designed footprint layout. They report their observations to management as appropriate. The Marshall supervisor may also be recommended and utilized to perform other additional POA duties.

POOL GATE MARSHALL TEMP STAFF SUMMER EMPLOYEES: A temporary POA staff team and a supervisor are under consideration to be hired to perform duties ENTRY MARSHALLS during the pool season. Temporary staffing will be sought from personnel that have backgrounds such as with the military, police, fire, safety, teachers, and other similar professional types.

LIFEGUARDS: were deemed as not required as our pools are "use at own risk"

CAMERA SYSTEMS: not recommended; have been attempted in the past and determined to not be cost feasible.

SECURITY GUARDS: were recommended for intermittent use this year as performance has improved.

In closing the pool use policy changes are being considered to improve our member experience for one of our key amenities.

PROPOSED Future Pool Rules and Information

Violation of any Rules could lead to suspension or loss of Pool Use Privileges

- SWIM AT YOUR OWN RISK. No lifeguards on duty
- No alcoholic beverages, glass, or food allowed
- No tobacco products-this includes cigarettes, cigars, chewing tobacco, e cigarettes or vaping
- No running, pushing, dunking, rough play, or any type of personal conduct endangering safety of self and others is allowed
- No diving or flips from the side allowed
- No animals, other than certified service animals
- Be courteous to your neighbor. Rude behavior is not allowed
- All bathers must shower before entering pool
- Do not enter the pool if you have an open cut or sores, or if you are ill with diarrhea, nausea, or nasal or ear discharge, or have any contagious condition
- Pools are available to all Member Residents in good standing of LFPOA
- Pools are available to Rental Residents Non Member when the Property Owner is a member in good standing of LFPOA and if an annual amenity card has been purchased.
- Adult Swim Hours 18 and above to be determined. Swim and Racket Pool may become an Adult Swim Only Pool
- At all times, all children under 16 must be under adult supervision
- Swim Diapers are required for all children who are not toilet trained
- Tampering with the Access Gate is not authorized and could lead to loss of pool privileges
- Members MUST use active POOL GATE PROX card to enter and have a POA Membership Card
- Sharing of Pool Gate Entry Cards with the general public, a non-member or with a member that is not in good standing is not allowed and WILL lead to loss of pool privileges
- Members in good standing can invite up to 4 total guests per day
- Damage to any property or grounds could lead to suspension and loss of pool privileges
- Hours of operation are posted.
- Anyone entering the pool or pool area outside of the pool hours of operation is trespassing and will be subject to arrest

Inclement Weather Policy

- All swimmers must exit pool during thunderstorms
- Pool will reopen 30 minutes after lightning strikes cease

Pool Closure

- Immediate closure will occur if there is contamination caused by discharge of fecal matter
- Closure for Safety related concerns can occur when necessary

Pool Events and Parties Policy

- No Pool Parties are allowed inside gated areas of Montclair Pool or Ridgewood Pool
- Pool Parties at our Swim and Racket Pool are allowed by appointment.
- Contact the POA office to schedule a party. A cleaning service fee will also be required.

POOL GATE CARD INFORMATION

Members will need a magnetic "POOL GATE ENTRY" PROX card to access the pools. Get your POOL CARD at the Lake Forest POA office to fill out the request and pay an annual service fee. A POOL CARD will be issued to members in good standing once the service fee has been collected and a signature card for our Pool Policy Rules and Regulations has been signed.

Our Pools are for the enjoyment of our members. Please enjoy and obey our pool rules for your safety and for the safety of your neighbors.

City Liaison Update

- **ROAD RESURFACING for 2023** Planned and budgeted City of Daphne paving is nearly completed for 2023 in our area; some minor work remains.
- ATT DAMAGED UTILITY BOX AT BAYVIEW AND RIDGEWOOD REPAIRS Are underway; ATT has
 indicated the work should be completed within the next 60 days. Repair delays were caused by lack of
 available parts. The utility box is planned to be relocated to help prevent future damage.
- **ZONING** / **ALLOWABLE HOME Business** primarily; Lake Forest residential area is zoned as R-3 or R-4 multi-family in some areas. Residents that fall under the jurisdiction of these zoning classifications that are operating a Home Based Business are required to follow existing city ordinances, policies and LFPOA house and ground rules. Please refer to the zoning table of allowable use.
- CAR WASH Location Adjacent Highway 90 and Bayview Drive (front portion of HOME DEPOT parking lot) request has been withdrawn.
- SIDEWALK PLANS FOR LAKE FOREST for 2023 Next phase being planned by the City is the connection from Ridgewood Drive (near Montclair Drive) to the triangle intersection of Bayview and Ridgewood. Engineering and design plans are currently in progress and are expected to be complete before the end of the year. Funding for sidewalks is expected to be encumbered.
- GRANT AWARDS \$7.2 MILLION DOLLARS for CITY OF DAPHNE (Bayfront Park and Amphitheatre) Recently Governor IVY announced \$67 million dollars worth of GOMESA Grant Funds were announced for the Baldwin County and Mobile County areas Daphne received a \$7.2 million dollar grant for the improvements of our Bayfront Park and to construct an Amphitheatre on Mobile Bay. Congratulations to the City of Daphne, to our Mayor Robin LeJeune for his vision and for his support for this long sought after project.

- MAY DAY PARK (located in Old Towne) Planned renovations by the City of Daphne are expected to be completed by the end of August 2023. Boat Ramp, kayak ramp and pier will be available for use.



News from our State House Representative Matt Simpson

As we head into the fall and the excitement of a new school year, we are also looking forward to positive changes for Baldwin County through enhancements made possible with nearly \$37 million in GOMESA funds allotted to our area this year.

The Gulf of Mexico Energy Security Act, GOMESA for short, is money allotted to communities in Alabama, Louisiana, and Mississippi from the revenue generated by oil and gas production off of our collective shorelines in the Gulf of Mexico.

Since the region began receiving those funds in 2006, Baldwin County has received millions to put towards projects that otherwise would have taken decades to fund through conventional means or may even have been left undone.



Daphne Utilities received \$187,000 to completed needed work at a facility on Highway 90. In Spanish Fort, \$3 million was given to make improvements to the causeway.

Funds were also distributed to other projects around the county to include the construction of an amphitheater in Robertsdale (\$2 million), beach renourishment in Fairhope (\$620,000), park expansion in Foley (\$5 million) and new boat ramps on the Bon Secour River in Gulf Shores (\$4.8 million).

We are thankful for all the great improvements these funds allow us to make across Baldwin County. This is the greatest place in America to live and work and each year the GOMESA projects just help to make Baldwin even better.


