I acknowledge the right of Lake Forest Yacht & Country Club to close or limit facility use for the purpose of scheduled maintenance, severe weather conditions, scheduled outside events, or any other purposes deemed necessary. I also acknowledge that a cart is for two (2) people and does not imply that a single membership means exclusive use of a two person cart when another player is available for pairing.

I agree to abide by the Rules & Regulations of Lake Forest Yacht & Country Club at all times and understand that the privilege of this membership may be suspended or cancelled for failure to abide by said Rules & Regulations. I understand that the Annual Membership is non-transferable, non-refundable and may only be used by me and my family, if applicable. Family is defined as individual, spouse, and children under the age of 21. I understand that Annual Membership program may be discontinued at any time, and that Lake Forest Yacht & Country Club will honor any and all existing commitments at that time.

Resignation

A member wishing to resign must notify the Club in writing that the membership is resigned. Resignation will be permitted in accordance with the terms and conditions of the Club Rules and Regulations. All dues and other charges for which a member is liable are due in accordance with the terms of the Club Rules and Regulations.

Payment of Accounts

Club accounts are due and payable upon receipt of the monthly statement. All past due accounts are subject to a late fee, as set forth in the Club Rules and Regulations. All costs and expenses incurred by the Club in the collection of any amounts not paid when due, including, but not limited to court costs and attorney's fees, whether at the trial or appellate level, shall be my obligation and I agree to be jointly and severally responsible for all charges and expenses as may be incurred by family members and guests.

Hold Harmless

I hereby acknowledge that the use of the Club facilities and any privileges or service incident to membership in the Club is voluntary and that any use or acceptance of any service or privileges incidental to membership is undertaken with knowledge of the risk of possible injury. I hereby accept any and all risk or injury.
